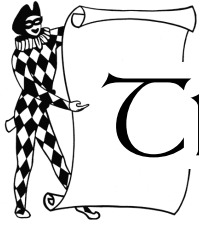

In addition to elections to the Board of Directors, there will be discussion and updates about the direction that the Indiana Players are heading. We need your ideas and input to determine our future.

Any current member age 18 and older may run for a position on the Board. Any current member age 16 and older may vote. Memberships can be updated at the meeting before the elections take place. Board of Director offices up for election are:

**Vice President—**

Duties include performing all duties of the president when that person is absent.

**Treasurer—**

Duties include keeping and maintaining accounting of the corporation's business transactions, budgets, and reports.

**Recording Secretary—**

Duties include keeping minutes of all meetings.

**Hard Tech Director—**

Duties include maintaining a working inventory of construction tools and materials, and maintaining lighting and sound systems.

Refreshments will be available. Our general meeting occurs only once per year. Please plan to attend. Remember, this is *your* community theater.
